Vol ADD – Voluntary deduction to pay for Accidental Death and Dismemberment Insurance

Vol Life CH – Voluntary deduction to pay for life insurance for your dependent child (children)

Vol Life EE – Voluntary deduction to pay for additional life insurance for yourself

Vol Life SP or DP – Voluntary deduction to pay for life insurance for your spouse or domestic partner
