

2012 Summer Supplemental Financial Aid Application

PRIORITY DEADLINE: MARCH 16, 2012



You must be admitted to a regular credential or degree-seeking program at USD in order to be considered for financial assistance during Summer. Priority is given to students who submit this application by the USD **priority filing deadline of March 16, 2012**. USD must also have your processed 2011-2012 Free Application for Federal Student Aid (FAFSA), and you must be enrolled at least half-time, in order to be considered for federal loans.

Financial assistance for students enrolled in Summer Session 2012 is limited to loans, and the Federal Pell Grant. Due to limited funding, USD Scholarships, Grants, Trust Loans and Perkins Loans **will not** be available. Pell Grant eligibility is limited to undergraduate students who have not used their full Pell Grant Scheduled Award during the academic year. If you enroll at least half-time (6 units as an undergraduate; 4.5 units as a graduate), you will be offered federal student loans, unless all of your federal loan eligibility has been used during the 2011-2012 academic year.

You will receive a revised *Financial Aid Award* through the *MySanDiego* portal when your financial aid eligibility for Summer has been determined. Links to loan applications and information will appear through the Active Messages link under your 2011-2012 Financial Aid Status on the One Stop Services page of the portal. You will need to complete the appropriate loan application in order to receive the funds listed.
