**GENERAL INFORMATION**

Financial aid funding for the 2010 January Intercession will normally be limited to unused federal loan eligibility (**Federal Stafford, Unsubsidized Federal Stafford, Federal Graduate Plus Loan** and/or **Federal Parent PLUS**). Please note that private Alternative Loans are also available. The loan application for the loan listed on your Financial Aid Award Offer for Intercession lists the steps necessary for processing.

Due to limited funding, USD scholarships and grants, Federal Perkins Loans and USD Trust Loans are not usually available for the 2010 Intercession.

Students with academic year Federal Work-Study awards may be able to work during Intercession. To be eligible you **must** be enrolled at USD for the 2010 Spring semester and be given permission to work by both the department in which you work and the Student Employment Center.

**Requirements to qualify for 2010 January Intercession Financial Aid**

- Completed 2009/2010 financial aid application (FAFSA) processed and on file in the USD Office of Financial Aid
- Enroll for a January Intercession class at USD (unless applying for Federal Work-Study (FWS) only; in which case, you must be enrolled for the Spring 2010 semester)
- If applying for a loan, read and follow all instructions to insure proper processing of your application

**Requirements to qualify for 2010 January Intercession Federal Work-Study**

- Federal Work-Study listed on your Financial Aid Award for Spring 2010
- Request FWS on the January Intercession Supplemental Financial Aid Application
- Obtain approval to work from the department in which you are employed
- Submit a completed Intercession Work Referral to the Student Employment Center (SEC) **BEFORE** starting work.
