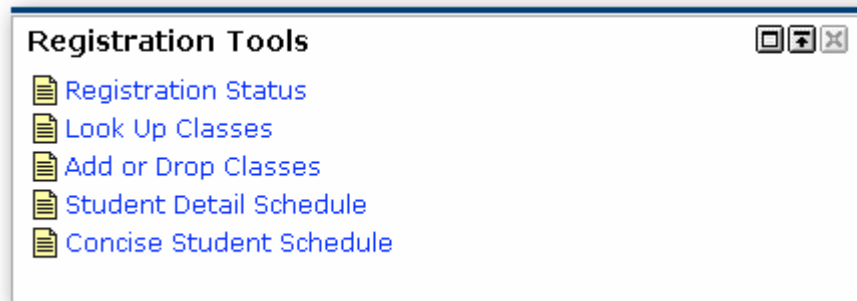



## Viewing the Course Schedule

1. To view the Course Schedule for any given semester, navigate to the **Law Student** tab in the MySanDiego Portal, <https://my.sandiego.edu/cp/home/displaylogin> On the **Registration Tools** channel, click on the **Look Up Classes** Link (see below).



2. Select the appropriate semester from the drop down menu and click **submit**
3. In order to view **ONLY LAW** courses:
  1. Enter "**LW**" in the "**Course Subject**" search field. Then select "**Blocks**" from the "**View As**" drop down menu and click **submit**. This will return the complete schedule of LAW course offerings (see below).

- II. Scroll down to the middle of the search page. From the “**Special Term**” drop down menu select “**Law Spring, Law Fall, or Law Summer**”, view as “**Blocks**”, and click **submit**. This will also return the complete schedule of LAW course offerings (see below).

4. Important things to note to understand your search results:
- “**R**” in the “Days” column represents **Thursday**.
  - “**TR**” in the “Days” column represents **Tuesday AND Thursday**
  - Make a special note of the “**CRN**” number for the courses you are interested in. The CRN number is what you will eventually use to register for the class.
  - “**W**” in the “Course Requirements” column represents a **Paper** class.
  - “**S**” in the “Course Requirements” column represents a **Law Professional Skills** class.
  - You cannot save the results from any one search, and build on them. This particular search program is designed to perform a new search every time you want to change or filter your search results.

6. Other helpful hints to be sure you see all the necessary information about LAW courses:
- o While the “**Blocks**” view may not be the easiest way to scroll through the schedule it is the *ONLY* view that displays detailed information about the available courses. You are responsible for the information contained in this view. As a result, we suggest you use it as your default view when searching.
  - o You may also export the entire schedule into MS Excel. This will allow you to manipulate and filter the data however you like. However, once again *ONLY* the “**Blocks**” view of the schedule contains all the necessary course details.
    - To export into Excel, follow the steps above to select LAW specific courses, and set the “**View As**” field to “**MS Excel**” (see below).
