- d. Statement from Dr. Cynthia Avery, Assistant Vice President of Student Affairs (15 min)
 - i. I appreciate the opportunity to share information with you regarding the leadership training on Saturday. I would like to



make a respon<u>S</u>T<u>U</u>D<u>E</u>N<u>T</u> uestions, however, first I would like to explain GOVERNMENT UNIVERSITY OF SAN DIEGO prior to the training:

- 1. Four days prior to the training I met with Nick
- 2. He said he wanted to discuss active listening and share his favorite TED talk video
- 3. I shared I thought it was extreme and asked him to cut out the most triggering aspects of the video
- 4. I anticipated that he would put context around the video and put trigger warnings after the meeting but he did not
- ii. I am extremely sorry for the impact that video had on students on that day and days following
- iii. I stand before you today having recognized that my white silence and complacency when I did not tell him unequivocal that he could not use that video due to its tokenization and perpetuation of harm.
- iv. The journey to anti-racism is a lifelong one, this journey is never over and I recognize the more I learn the more I have to learn and to unlearn.
- v. I carry with me the sorrow of having harmed this community and know the blame is on me and not to place on others
- vi. Questions
 - 1. What is going to happen to Nick
 - a. He will no longer be working with the TPB. As this is a personnel matter I am not able to publicly comment further (confidentiality issue)
 - 2. How are graduate assistants trained?
 - a. Engage in intensive work inside the classroom
 - b. Train as a cohort
 - c. This question has caused us to review the questions asked during the interview process of GA's
 - 3. Is my position under review?

- a. I <u>STUDENT</u> continued to be in dialogue about th<u>GOVERNMENT</u> situation has evolved. I am committing to continuing my self work, education, and development to ensure i better understand and deconstruct ongoing power, privelide, and oppression
- b. As a human I will continue to make mistakes I commit to you I will do my best to make sure that this doesn't happen again.
- 4. Why do I not stay for the duration of the meeting?
 - a. It's entirely dependent on the week. As you know torrero hours are anything but dead hours I try to be at senate meetings for as long as I can but often there are multiple meetings that occur at this time, meetings with students, faculty, etc.. However, we do have a great group of advisors here to comment.
- 5. Did I make a comment about someone or the group playing the victim card?
 - a. Unequivocally no, I would never try to diminish the feelings of others particularly those who are marginalized in our community everyday. This is not a term I have ever used about any group and never will.
- 6. What exactly is my job?
 - a. Support ASG, TPB, and student organizations
 - b. Supervise nine student life administrators
 - c. Work with each area of the commons, fraternity and sorority life, graduate student life, commuter commons, military and veteran's program
 - d. Direct the Torrero Renaissance program
 - e. Serve on approximately seven committees and task forces across campus

I would like to close by reinforcing that I am committed to continuing to explore my white privilege as well as interrogate, can clarify, and dismantle the ways in which I reinforce oppression. I believe everyone deserves to be treated with dignity, respect, love, and compassion. This is an ongoing journey that I am determined to continue and I truly appreciate the willingness to listen and continue ongoing conversations.
- viii. Questions
 - 1. Chidi If possible would doctor avery be able to take questions from the public at this time?
 - a. Yes, of course
 - Drew Thank you for coming here today. I want to know what you're going to do personally to do better? Actions speak louder than words.
 - a. There are three things i've engaged in immediately
 - i. I'm listening to an audiobook about mindfulness and racial healing
 - ii. Completing a workbook called the handbook for racial justice
 - iii. Engaging with other white faculty members and talking about a book called me and white supremacy
 - b. Additionally, I strive to learn about more groups on campus all the time. I just went through the safe space ally training last week.
 - 3. Eniya Are you engaging with black or brown colleges in this or just white colleagues?
 - Yes, I will be engaging with black and brown colleagues as well. We are reviewing a book about me and white supremacy as well. It is a

- 4. Ellie What is being done to uphold not only you but other faculty members accountable? Is there training? Do these force you to come out of your comfort zone? How are you going to put that into action to ensure that black students are safe at this campus?
 - a. Within our division we do training and across the campus there are opt-in training. I wish that we could require faculty members to go but at this time we don't have the mechanism to force faculty members to go.
- I want to know how the people who made this video didn't reach out to student organizations directly involved in these groups to determine how to respond to this situation.
 - a. I wanted to start with working first with the students who were directly involved and will reach out further in the future.
- 6. Jesse If international corporations like starbucks can close all of their stores for an entire day to go through racial bias training then this school can do the same. I would go so far to write a resolution to ask the administration to do that. The president of this university is a white male and he himself is not engaging in this dialogue so I don't think it will trickle down to the bottom where these conversations should be happening. I think the people at the top of the hierarchy should be having these meetings, so that we can make sure this message is being spread as often as it can

- 9. Kwamina Do you think all of this is going to be enough? Is this where it stops?
 - a. I can speak for myself and that I'm committing to doing ongoing work. I can't commit to the rest of the institution. I will take this information forward to encourage ongoing training of my colleagues, peers, and those above me.
 - b. Alanna I think another addition to training could be talking about where do we draw the line between overcoming difference and then tolerating hate, tolerating violence, tolerating harm. As a person of color that is often a battle I have with myself. My parents raised me to always be kind, but that's obviously different than making your oppressor your friend or becoming a member of the oppressors altogether.
 - c. Greyson Thank you for that statement. I was wondering about the awareness level of President Harris about this event?
 - i. I am not sure. President Bosque would communicate with him and she is not here right now
 - d. Drew You mentioned that a lot of the steps you are taking are primarily with white people. Do you think that's a good idea?
 - I am doing that as well and some of the authors of the books are black individuals. The white groups and there is only one is to
