REVEREND RUBÉN ARCEO

Pastor, St. Francis of Assisi Catholic Church

Reverend Rubén Arceo became the Pastor of St. Francis of Assisi Church in Vista, California on July 1, 2016.

Fr. Arceo was born in Mexico and raised in Los Angeles, where he completed his studies from elementary school through college. In 1989, he joined the Society of Jesus, a religious order in the Catholic Church, in the Mexican Province. He received his religious vows on July 31, 1992 and was ordained on December 14, 2004. After his ordination, Fr. Arceo was assigned to various educational institutions as a professor and administrative leader from 2004-2016.

Prior to joining St. Francis of Assisi Church, Fr. Arceo served as president of the Universidad Iberoamericana Tijuana and professor in the Doctorate Program in Education. During this time, he served on the Board of Trustees for the University of San Francisco in California. Fr. Arceo is a priest of the Diocese of San Diego and currently serving as Pastor of San Francis of Assisi Church in Vista, CA. He has been serving USD Board of Trustees since 2016.

Fr. Arceo received his Ed.D in Catholic Education Leadership from University of San Francisco in 2010; M.A. in Educational Leadership and B.A. in Philosophy and Social Sciences from Instituto Tecnológico de Estudios Superiores de Occidente (ITESO) in Guadalajara. After completing his studies in Guadalajara, he was reassigned to a new mission in México, City, where he acquired a B.A. in Religious Sciences and Divinity from the Universidad Iberoamericana in Mexico City. In addition to his leadership and administrative positions, Fr. Arceo has taught at the middle school, high school, undergraduate, and graduate levels at Jesuit Schools.



JON BALOUSEK

Jon Balousek is an experienced corporate executive and board director.

He currently serves as a Board Director and CEO of Primal Pet Group, a premium dog and cat food and treat company owned by Kinderhook Industries Private Equity. He is responsible for the overall strategy, execution, and performance of the Global business.

Jon also currently serves as an Advisory Board Member for Fetch Rewards, a consumer loyalty technology platform with over 17 million unique users.

Prior to this, Balousek spent several years as President, Corporate Development, for Central Garden and Pet where he oversaw all M&A activity, and 25 years at The Clorox Company—his last role being Executive Vice President of the Specialty Division and Corporate Development. In this role, Balousek had full P&L responsibility for five business operating units representing \$2.8B in sales, 13 manufacturing plants, and over 3,000 employees, as well as M&A and partnerships/licensing. During his Clorox tenure, Balousek held various General Manager roles as well as senior Marketing roles, including running Marketing for the two biggest Divisions in Clorox. Throughout his career, Jon has grown many iconic consumer brands through strong product and commercial innovation as well as smart cost controls.

Balousek has also held leadership positions on several nonprofit boards including the Conservation Society of California/Oakland Zoo Board of Trustees, where he was part of the effort to double the size of the zoo during his tenure, the Multi-Cultural Institute of Berkeley Board of Trustees, and the St. Isidore School Foundation Board of Trustees.

Balousek holds a Bachelor of Arts Communications degree from UCLA and is married to Jane Balousek (Rollo), University of San Diego class of 1991. They have three children and reside in Alamo, California.



TOM BREITLING

Founder and CEO, Breitling Ventures

Tom Breitling is founder and Chief Executive Officer of Breitling Ventures, a private investment management business. He holds a Bachelor of Arts degree in Communications and a minor in Business Administration from the University of San Diego.

Breitling is also a founder of Trifecta Hospitality, a collaboration of hospitality and development leaders who are bringing their expertise to the experiential travel market in a very innovative and entrepreneurial way.

Mr. Breitling has extensive experience in the travel and travel technology industries and his entrepreneurial focus is shaped by his success and experience in other areas of business. Breitling met his business partner Tim Poster in 1989 while attending USD, and he eventually moved to Las Vegas in 1993 to join Mr. Poster to help run their startup travel company. Breitling and Poster revolutionized the travel industry and turned the company into one of the world's largest consumer-direct hotel room distribution systems. They capitalized on the growth of Las Vegas, the overall hospitality industry, and of the Internet, propelling sales to \$104 million in 1999. A year later, the partners oversaw the acquisition of their company, Travelscape, by Expedia, Inc., in a deal valued at more than \$100 million. Breitling was a member of the board of directors of Expedia in 2002 and 2003.

In 2004, with their first venture into the gaming and hospitality business, Breitling and Poster acquired the Golden Nugget hotel-casino properties in Las Vegas and Laughlin, Nevada, from MGM Resorts for \$215 million and became the youngest casino owners in the state. In September 2005, the pair sold the Golden Nugget to Landry's Restaurants Inc. for approximately \$340 million.

Breitling published his autobiography, "Double or Nothing," in 2007, worked at Wynn Resorts from 2008 to 2010, and founded an online gaming business with Frank and Lorenzo Fertitta, which in 2013 became the first company to bring regulated real-money online gaming to Nevada and the United States.

Breitling is currently a member of the executive committee for the Shriners Children's Open golf tournament in Las Vegas, a board member for the College Loan Corporation, a member of the University of San Diego Board of Trustees, and an honorary commander for the Nellis Air Force support team. Breitling supports a variety of philanthropic efforts in Nevada and lives with his wife Vanessa and their three daughters in Las Vegas, Nevada.



KIM BUSCH

Co-Owner, Folded Hills Winery, Farmstead, Ranch

Kim Busch with her husband, Andy, are the founders and owners of Folded Hills Winery, Farmstead & Ranch. Folded Hills is an artisanal, boutique winery that produces award winning wines from organic grapes grown on the estate. Folded Hills has two tasting rooms, an urban tasting room located in Montecito, and the Estate Tasting Room at the Homestead located in the southernmost region of the Santa Ynez Valley. Folded Hills has been named the winery to watch in California by Wine and Spirits magazine, and the wines have received one of the Top Roses of 2016 and 2018 as well as points in the 90's by Robert Parker, Jeb Dunnuck and Wine Enthusiast.

Kim has been very active in the philanthropic communities of both St. Louis, Missouri and Santa Barbara, California. Kim and Andy manage multiple businesses in the fields of real estate, hospitality, catering, and organic and biodynamic farming and viticulture. They have four children, a daughter who graduated from University of Virginia in 2005, and three sons who have attended the University of San Diego. Kim is the co-founder of the Andrew D. Busch Family Foundation.



CHRIS CARR

Executive Vice President, Starbucks Coffee Company (Retired)

Most recently, Chris served as the Chief Operating Officer at Sweetgreen, the fast-casual salad restaurant chain which was recently named the "most innovative" company by Fast Company magazine, where he was instrumental in supporting the company's successful initial public offering.

Prior to Sweetgreen, Carr was a former Executive Vice President for Starbucks Coffee Company. He most recently served as EVP, Chief Procurement Officer, where he was responsible for shaping the global supplier base spend of \$7.5 billion and accelerating customer-insight driven innovation. Most of Carr's Starbucks experience was leading two of their largest business units. As the EVP, Licensed Stores Americas, he was responsible for the strategic planning, annual operations, market planning and sales for 6,500 licensed stores, generating \$3.4 billion in systemwide sales. He worked in partnership with other Fortune 500 companies to ensure that the Starbucks brand was positioned to exceed the expectations of our customers across multiple segments, including: retail, travel, college & university and hospitality.

As Executive Vice President U.S. Retail Stores, he was accountable for the brand and customer experience across 13,000 company-operated and licensed retail stores that generated revenues of \$15 billion. Carr played a critical role with developing and implementing several key strategic initiatives in both the physical and digital space that delivered all-time highs in partner engagement, customer satisfaction and shareholder value.

Prior to joining Starbucks, Carr spent most of his career with ExxonMobil, developing, leading and implementing retail operational strategies for its Global Fuels Marketing downstream businesses. Over his career he has been recognized for his leadership contribution and was the recipient of Savoy Magazine's 2016 and 2018 top 100 Most Influential Blacks in Corporate America, 2021 Most Influential Black Corporate Directors in America, and recognized as one of Black Enterprise's 2017 Most Powerful Executives in Corporate America.

Carr holds a Bachelor of Science degree in Business Administration from the University of San Diego, and a Master of Business Administration degree from the New York Institute of Technology. He serves as a board of director for Hilton Worldwide Holdings Inc, Recreational Equipment Inc. (REI) and Bridgestone Americas Inc, he also serves as a Trustee of Howard University, and a Trustee of the University of San Diego.



CURTIS CHAMBERS

Curtis Chambers is a San Diego native and USD graduate that has been a serial entrepreneur over the last 20 years. During that time he has helped build 5 companies, the most recent of which was Uber, which he joined in 2010 and served as the first head of engineering. Later in his tenure at the company, he served the same role in creating UberEats and UberFreight. Prior to building Uber, he was the first employee at Expensify, a company that provided a new and novel way to do expense reporting.

Before becoming an entrepreneur, he was a math teacher at a local high school and very passionate about education, specifically around ethnomathematics and the various ways different cultures teach mathematics. He brings that passion for education and pushing the envelope in terms of teaching subjects with new techniques and finding ways to engage the students in non-traditional ways.

He and his wife currently devote most of their time to their two daughters but also find some time for their philanthropic ventures in providing clean water, education and gender equality throughout the world.



SUZANNE COOKE, RSCJ
Provincial, Society of the Sacred Heart
United States - Canada

Sister Suzanne Cooke currently serves as the provincial of the Society of the Sacred Heart in the United States and Canada. Appointed in 2021, Sister Cooke and her provincial team have responsibility for the oversight of the province's apostolic service and communal life, which includes the care of sisters who are sick or elderly, collaboration with lay people including associates, and a commitment to the future of the congregation in North America.

Prior to this, Sister Cooke served as head of the newly created Conference of Sacred Heart Education beginning in 2015. The mission of the Conference is to ensure mission effectiveness by creating opportunities for leaders of Sacred Heart Schools to engage in thoughtful dialogue and discernment with the provincial team about Sacred Heart education. The Conference addresses issues regarding accountability, governance and education to mission.

Sister Cooke has held numerous leadership positions as an educator. She was head of school at Forest Ridge School of the Sacred Heart in Bellevue, Washington, from 1990-1998, and at Carrollton School of the Sacred Heart in Miami, Florida, from 1998-2015. Notably, she has served on several Network schools' board of trustees and as a member of the Sacred Heart Commission on Goals, the Network of Sacred Heart Schools board, the Northwest Association of Independent Schools and Florida Council of Independent Schools. In 2000 and 2016, Sister Cooke was a delegate to the General Chapter of the Society of the Sacred Heart, the governing body of the international Society that represents all RSCJ. She holds a bachelor's degree in English and history, cum laude, from Manhattanville College in Purchase, New York, and a Master of Arts in interdisciplinary studies from the University of Chicago in Chicago, Illinois. Sister Cooke is guided by the three dimensions of the Society's mission: spirituality, education and justice with a priority for young people. Her leadership guides the Society in the work of teaching and formation, in activities for human development and the promotion of justice as well as pastoral work and guidance in the faith. Together with her team, she engages the entire Sacred Heart family in a collaborative way to live out the mission of discovering and revealing the love of God in the heart of the world.



SUE CUNNINGHAM

Sue Cunningham is President and CEO of the Council for Advancement and Support of Education (CASE), which supports over 3,000 schools, colleges and universities worldwide in developing their integrated advancement work (alumni relations, communications, fundraising and marketing operations). As CASE President and CEO, Ms. Cunningham provides strategic and operational leadership for one of the largest associations of education-related institutions in the world with members in over 80 countries. She started her leadership role at CASE in March 2015.

While at CASE, Ms. Cunningham has engaged CASE in two strategic planning processes. The first, which engaged thousands of CASE volunteers, resulted in [*Reimagining CASE: 2017-2021*](#), and created an ambitious framework for serving CASE's members and championing education worldwide, which included a comprehensive restructure of CASE's volunteer leadership and governance structure. Building on the strengths of this plan, she led a recalibration exercise that resulted in *Championing Advancement: CASE 2022-2027*. This Plan articulates a clear strategic intent: that CASE will define the competencies and standards for the profession of advancement, and lead and champion their dissemination and application across the world's educational institutions.

Among the key initiatives that have developed under her leadership include the redesign and delivery of a new global governance structure. In addition, CASE acquired the Voluntary Support of Education survey and created CASE's Insights, CASE's global research and data efforts. CASE published the first global and digital edition of CASE's Global Reporting Standards and Guidelines, which operate as the industry-leading Standards for the profession, and launched the first global Alumni Engagement survey in addition to annual fundraising surveys. CASE created an ambitious competencies model across all advancement disciplines and a related career journey framework; opened the CASE Opportunities and Inclusion Center which focuses on equity, diversity, inclusion and belonging; and has reinvigorated a global advocacy agenda to communicate the value of education. Ms. Cunningham serves as a Trustee and Secretary for the University of San Diego, and is a member of the Executive Committee of the Board. She is a member of the Signature Theatre (Arlington, Virginia) Board of Directors, Chairs their Governance Committee, and sits on the Executive Committee. She is a member of the Washington Higher Education Secretariat steering committee, the International Association of University Presidents Executive Committee, and the International Women's Forum. She is the author of '*Global Exchange: Dialogues to Advance Education*'.

Prior to her appointment to CASE, Ms. Cunningham served as Vice-Principal for Advancement at the University of Melbourne where she led the *Believe* campaign resulting in surpassing its original \$500 million goal; and the Director of Development for the University of Oxford where she led the development team through the first phase of the largest fundraising campaign outside of the United States (at the time): *Oxford Thinking*, with a goal of £1.25 billion. She served as Director of Development at Christ Church, Oxford and as Director of External Relations at St. Andrews University.

Before working in education, Ms. Cunningham enjoyed a career in theatre, the arts and the cultural sector. She is an Honorary Fellow of the Melbourne Graduate School of Education and a fellow of the Royal Society of Arts. In 2012, Ms. Cunningham received the CASE Europe Distinguished Service Award, and has received the coveted CASE Crystal Apple Award for Excellence in Teaching. Ms. Cunningham was awarded a master's degree from the University of Oxford, a bachelor's degree in performing arts from Middlesex University, and is a graduate of the Columbia University Senior Executive Program.



JACQUELINE LEHN DUPONT, Msg, MPa., PhD., EdD

Jacqueline Dupont is the founder and former Chief Executive Officer of Dupont Residential Care, Inc., Irvine Cottages Memory Care, Vista Gardens Memory Care, LLC, and former owner of Assured Horizons Senior Living LLC. She currently owns Assured In Home Care, Inc., serving Orange and Los Angeles counties. She is the CEO of a new start-up technology company, Senior Care Map, an innovative way to assist older adults with moving into senior living communities.

Dupont brings over 30 years of professional experience working with older adults and the Alzheimer's community and serving on several nonprofit boards. Jacqueline received the 2010 UCI MIND Philanthropy Award for outstanding service to UCI Mind, where she served on their board and funded Alzheimer's research. She served six terms of service (20+ years) on the Board of the Alzheimer's Association of Orange County Chapter, now Alzheimer's of Orange County. She also served six years on the J Serra Catholic High School board. She served on the Orange Catholic Foundation Board for 8 years and was awarded the Orange Catholic Foundation Bishop's Award for Exemplary Business Ethics and Integrity in 2011. In 2015, she was awarded the Humanitarian of the Year by SeniorServ and the Aging community. In addition to those honors, she was Mother of Year at St. Anne School, where all of her children attended, and she also was Alzheimer's Orange County Visionary Woman of the Year 2006, Philanthropist of the Year for JSerra Catholic High School 2010. In 2019, Jacqueline donated all her Alzheimer's community companies, known as Irvine Cottages, to Alzheimer's Orange County, and she is proud of the work they are doing in our community. In 2022, Jacqueline was awarded the National Philanthropy award in Orange County, California, for her work with the marginalized. In 2023, she was awarded the Illumination Foundation Women's Philanthropy Award, and in 2024, assemblywoman 74th District awarded Jacqueline as "Woman of the Year 2024" for her work with older adults.

Dupont is the past Chairman of the Board of Directors for Illumination Foundation (serving the homeless and unstably housed). She is passionate about serving the marginalized, vulnerable, and frail on our streets today. Jacqueline is a member of Legatus, a Catholic CEO group in the South Bend, Indiana chapter. She attends with her husband, Marc, and her family belongs to the Basilica of the Sacred Heart at the University of Notre Dame. Jacqueline serves proudly on the USC School of Gerontology board of directors and the provost board at the University of Notre Dame. She is also a current board of trustee member at the University of San Diego, her alma mater.

Dupont graduated from the University of San Diego with a B.A. in Neurosciences, received her M.S. degree in Gerontology and M.A. degree in Public Administration at the University of Southern California, and her graduate certificate in Non-Profit Management from the University of Notre Dame, and her Doctorate in Psychology from Ashbourne College. She graduated from USC with a Doctorate in Education (EdD) in Organizational Development. She is attending USC, completing her doctorate in Longevity Studies at the USC Davis School of Gerontology. Dupont has published many articles and training programs for caregivers of older adults with dementia and Alzheimer's, as well as Systemic and Structural Ageism in our Healthcare system.

Dupont is a Gerontologist who has lectured at USC, UCI Notre Dame, and California State Fullerton on various Aging Issues. In June 2014, she was the Commencement Speaker for the U.C. Irvine Francisco J. Ayala School of Biological Sciences Commencement. In 2022, she was the commencement speaker at the USC School of Gerontology.

She was the International Sweetheart of Sigma Chi and is still active in Sigma Chi Alumni events nationwide. She has a Scholarship named after her, The Dr. Jacqueline DuPont Carlson Scholarship for exceptional college women at local university chapters to further their education. She continuously supports the Downey Kiwanis Foundation, founded by her father, Richard Lehn, Esq. for scholarships serving the disabled and those without parents to attend college.

Dupont has served as co-chair of the Peru Club's humanitarian missionary trips from 2009 to current times at JSerra Catholic High School. Parent volunteers and her husband have escorted 50 or more high school students at a time over the last 14 years to Piura, Peru. While working there, she performed humanitarian and healthcare training for students and native caregivers while working with the poorest of the poor at the local hospice. She and her husband have built numerous homes for the marginalized and sick.

Dupont has been featured on CNN, Dateline, Fox News, CNBC, The Wall Street Journal, Orange Coast Magazine, and in many newspaper articles about her passion for protecting and caring for older adults in America. For years, she debated her support of camera monitoring and the topic of safety vs. patient Privacy for older adults with memory loss and dementia with the State of California. Dupont is currently writing a fictional novel about grieving and memory loss, titled *The Cottage*, and she is working on academic journal submissions on Ageism and health equity for older adults.

Jacqueline has a devoted husband, Marc Carlson, who partners with her on everything. He is her role model for servant leadership and continuous mentorship to our youth and our family.

Mr. Hale is a serial entrepreneur who has been involved in the formation and development of a number of biomedical companies. He served as Chairman of Santarus, Inc., prior to its sale to Salix Pharmaceuticals, Inc. in 2014, SkinMedica, Inc. prior to its sale to Allergan in 2012, Micromet, Inc. prior to its sale to Amgen Inc. in 2012, Somaxon Pharmaceuticals prior to its sale to Pernix in 2013, Crisi Medical Systems prior to its sale to Becton-Dickinson in 2015, and he was a co-founder and Chairman of Agility Clinical, Inc., prior to its sale to Precision for Medicine in 2017.

In 1982, after joining Hybritech, Inc., the first monoclonal antibody company, Hale served as COO, President and then Chief Executive Officer, when Hybritech was acquired by Eli Lilly and Co. in 1986. From 1987 to 1997 he was Chairman, President and CEO of Gensia, Inc., which merged with SICOR to become Gensia Sicor, Inc., which was acquired by Teva Pharmaceuticals. He was a co-founder and Chairman of Viagene, Inc. from 1987 to 1995, when Viagene was acquired by Chiron, Inc. In 1997, he was a co-founder and served as Chairman of LMA North America until its merger with LMA International in 2004. Hale is also a co-founder and serves on the Board of Directors of BIOCOM and CONNECT, and is a former member of the Board of the Biotechnology Industry Organization (BIO), and the Biotechnology Institute. He served as Chairman of the Board of Trustees of Rady Children's Hospital and is a co-founder and Chairman of the Board of Rady Children's Institute of Genomic Medicine. He serves as a member of the Rady School of Management Dean's Advisory Council, and is a former Director of the Salk Institute, Sanford Burnham Prebys, and the San Diego Economic Development Corporation.



JAMES T. HARRIS III, DEd President, University of San Diego

James T. “Jim” Harris III, DEd, became the University of San Diego’s fourth president on Aug. 3, 2015. During his time as president, USD has been recognized as one of the top schools nationally for being a “best run college” and having the “best quality of life” by the *Princeton Review*, a top five program nationally for promoting public service by *Washington Monthly*, and has received additional recognition for its sustainability efforts and work to enhance diversity and inclusion. With an authentic, down-to-earth leadership style and an engaging personality, Harris creates meaningful connections with students and surrounds himself with student activities. He has a reputation at USD for being visible across the campus and always accessible to members of the campus community.

Harris is also a civically minded leader and educator, and, throughout his academic career, has worked closely with cross-discipline teams to spearhead new civic and community engagements, connecting academic environments with intractable issues faced by society. Under Harris’ leadership USD completed a series of essential campus infrastructural upgrades through an initiative known as the Renaissance Plan and launched the Horizon Project, a five-year initiative designed to move USD to the forefront on being more “open, inclusive and welcoming.”

Previously, Harris served for 13 years as the president of Widener University. During his tenure, the university completed its largest campaign, achieved the highest undergraduate enrollment in its history, improved the retention and graduate rates of students, and achieved national recognition for its work in civic engagement. Prior to his appointment at Widener, Harris was president of Defiance College in Defiance, Ohio, where he established the McMaster School for the Advancement of Humanity and developed a service-learning program that was ranked among the top 25 in the country.

He remains an active scholar and professor, teaching leadership courses. He is also interviewed regularly as a thought leader in higher education. In 2013, he co-authored a book titled, *Academic Leadership and Governance in Higher Education*, which he, along with several co-authors, revised in 2022.

He has also held numerous local, state and national roles including Chair of the Board of Trustees for the Council for Advancement and Support of Education (CASE); Vice Chair of National Campus Compact; Chair of the NCAA Division III Presidents Council; Chair of LEAD California, Chair of Monarch School Project, and a board member of the Association of Catholic Colleges and Universities. Harris has been the recipient of many awards and honors, including leadership awards from the NAACP and the Urban League for his work on defending civil rights. Earlier in his career, he was named by the John Templeton Foundation as one of the Top 50 Character-Building Presidents in America, and in 2011, he received the Chief Executive Leadership Award from CASE.

Jim earned his undergraduate degree from the University of Toledo, a master’s degree in educational administration from Edinboro University of Pennsylvania, and his doctorate in education from Pennsylvania State University. Jim is proud to be a first-generation college student. He and his wife, Mary, were married in 1982 and have two sons, Zachary and Braden.

Donald R. “Don” Knauss retired as the executive chairman of The Clorox Company in 2015. He joined The Clorox Company as chairman and chief executive officer in October 2006. As CEO, he had overall responsibility for directing the company’s worldwide business, which generated revenues of \$5.6 billion in fiscal year 2013.

Prior to joining Clorox, Knauss spent 12 years with The Coca-Cola Company. He joined the company in 1994 as senior vice president of marketing for The Minute Maid Company, and in 1996 was promoted to senior vice president and general manager for Minute Maid’s U.S. retail operations. Beginning in 1998, Knauss served nearly two years managing Coca-Cola’s businesses in ten countries of southern Africa. In 2000, he was named president and chief executive officer of The Minute Maid Company. He became president and chief operating officer of Coca-Cola North America in 2004.

Knauss previously held a variety of positions in marketing and sales with the Frito-Lay and Tropicana divisions of PepsiCo, Inc. He began his business career as a brand manager in the paper products division at Procter & Gamble. Prior to that, he served as an officer of the United States Marine Corps.

Knauss is a member of the Board of Trustees at the University of San Diego where he served as chair from 2016-2023 and is a member of the Board of Directors of the Kellogg Company, Target Corporation, and previously served as a director of the URS Corporation. In 2018, Knauss retired from the Economic Advisory Council of the Federal Reserve Bank of San Francisco. He has served on the Board of Directors for the McKesson Corporation since 2014 and was elected as Chairman of the Board on April 1, 2022.

Knauss has a long-standing commitment to promoting workplace equality and embracing diversity. In 2006, he received The Jackie Robinson Foundation’s ROBIE Award for industry achievement. The ROBIE Award is the foundation’s highest tribute to an individual who has promoted and expanded opportunities for minorities in the corporate world.

This annual program provided 15 children of Clorox employees as much as \$10,000 each — \$2,500 per year for a four-year program — to be applied toward accredited colleges and universities, as well as vocational and technical schools. In 2017, the Knausses extended their transformational philanthropy at the University of San Diego to provide the naming gift for the proposed new School of Business facility, Knauss Center for Business Education. In May 2020, the Knausses committed a \$5 million gift to the Texas A&M Foundation to support Texas A&M University’s Veteran Resource & Support Center (VRSC). The center will be renamed the Don and Ellie Knauss Veteran Resource & Support Center. In December 2021, the Knausses once again increased their philanthropic giving to the University of San Diego to \$50 million as their investment in educating ethical and compassionate business leaders. In honor of their remarkable gift, the business school at USD will be known as the Knauss School of Business.

Kimberly Koro is Senior Vice President, Qualcomm and General Manager of Government Technologies (QGOV). She has dedicated most of her career to supporting the national and homeland security of the United States through QGOV. QGOV is dedicated to working with

Clarity Design provides design and manufacturing services for companies serving a variety of markets, including FDA-registered medical devices. Clarity Design sponsored its first senior engineering project at USD in 2015 and continues to sponsor one or two senior design teams every year. Clarity Design has hired many USD engineers and has provided summer internships as well.

In addition to running Clarity Design, Lupfer is the CTO and co-founder of Rehabit Health, which has developed technologies for helping stroke and traumatic brain injury patients walk again. Lupfer is also the CTO of two other companies and holds eleven patents, with several more applied for.

Lupfer serves on the Advisory Council of the Krach Institute for Tech Diplomacy at Purdue. He is also the Tech Commissioner for Advanced Manufacturing and Robotics for the Global Tech Security Commission.

Reverend Peter M. McGuine currently serves as Pastor of the Mission Basilica San Diego de Alcalá Parish, San Diego, CA. After ordination he continued his graduate studies on a part-time basis at the University of Notre Dame (South Bend, Indiana). In 1994, he concluded those studies, earning a Masters degree in Liturgical Theology.

Father McGuine has served on the Diocese of San Diego's Finance Council and Clergy Personnel Board. He is a current member of Diocesan Art and Architecture Committee for the construction and renovation of sacred space as well as an appointed member of the Pension Committee for Priests of the Diocese of San Diego. After completing a four-year term as Chairman of the Board of Directors for Mater Dei Catholic High School in Chula Vista, California in 2013, he accepted an appointment to Board of Trustees of the University of San Diego from the late Bishop Cirilo Flores. From January 2015 through June 2022, he served as chairman of the Board of Directors of the Mater Dei Catholic High School Foundation, and in July 2018, he was elected as Chief Financial Officer for the Roman Catholic Services Corporation for Parishes and Schools in the Diocese of San Diego.

His assignments include: Associate Pastor, Good Shepherd Parish (Mira Mesa, California, September 1990 - November 1991); Director of the Office for Priestly Vocations, Diocese of San Diego (San Diego, California, November 1991 - August 1992); Associate Pastor, The Immaculata Parish (San Diego, California, February 1992 - July 1995); Director of the Office for Liturgy and Spirituality, Diocese of San Diego (San Diego, California, July 1992 - July 1995); Pastor, St. Thomas More Parish (Oceanside, California, August 1995 - August 2003); Vice Rector for Seminary Life and Director of Human Formation, Pontifical North American College (Rome, Italy, August 2003 - June 2007); Pastor, Santa Sophia Parish (Spring Valley, California, August 2007 – June 2013); Pastor, Our Lady of Grace Parish (El Cajon, California, July 2013 – July 2022); and Pastor, Mission Basilica San Diego de Alcalá Parish (San Diego, California, August 2022 to present).

Joining the United States Air Force as a Chaplain Candidate in May 1987, Fr. McGuine retired from the U.S. Air Force Reserve as a Chaplain, Lieutenant Colonel, in March 2014 after almost 27 years of service to our nation.

Tom Mulvaney has been a Private Investor and Community Leader since 2001. He manages and directs the assets of several real estate investment enterprises. 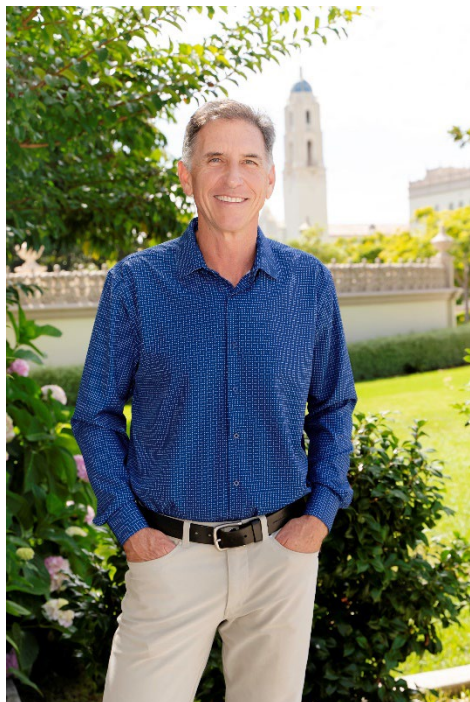
ALAN SCHULMAN

Mr. Scott serves on the Board of Avelas, a bioscience company working to create better outcomes for cancer patients with its activatable cell-penetrating peptide technology. Mr. Scott is past Executive Board Chair of CONNECT, a non-profit organization helping to create and scale innovation companies in San Diego. He serves as Chair of Biocom California, a non-profit organization supporting the needs of bio/pharma companies in California. DARLENE MARCOS SHILEY

Darlene Marcos Shiley has served on the Board of Trustees since 1990 and served as its chair from 2007-2010. She is the president of The Shiley Foundation and has the fiduciary responsibilities for multiple family trusts.

Shiley and her late husband, Donald, a pioneer in the medical device field, are recognized as community supporters. Their generosity has benefited the Old Globe Theatre, KPBS, numerous projects at Scripps Clinic, the UCSD Shiley Eye Institute, the award-winning Shiley School of Engineering at the University of Portland, and most recently the Shiley CSU Institute of Palliative Care. They have underwritten Alzheimer's disease research and funded centers for Alzheimer's care. The Shiley Theatre at USD was named in recognition of their contributions to the university. The Old Globe USD Shiley MFA program is now ranked number 7 in the world. Shiley co-chaired the Presidential Debate Host Committee in 1996 at USD. The couple also made the significant leadership gift to USD's Donald P. Shiley Center for Science and Technology and closed USD's successful initial capital campaign with a \$1 million gift to the School of Leadership and Education Sciences. In 2010, the Shileys established a distinguished professorship endowment in theatre honoring the late Craig Noel, and in the fall of 2013, Mrs. Shiley publicly announced her leadership gift to establish the nationally-ranked Shiley-Marcos School of Engineering at the University of San Diego.

An ardent arts patron, Shiley was a board member of the Old Globe Theatre and served on the City of San Diego Commission for Arts and Culture, KPBS' Community Advisory Board, National Board of the Alzheimer's Association, and retired as the Vice Chair of the Salk Institute. She was a member of the Alzheimer's Collaboration4Cure committee organized by the San Diego County Board of Supervisors and is featured as the public representative for PBS' Masterpiece Theatre series.

Shiley's numerous honors include the 1992 San Diego Press Club Community Activist Headliner of the year, UCSD Distinguished Service Medal, KPBS' first Woman of the Year and the Association of Fundraising Professionals (AFP) Volunteer of the Year. Shiley received Presidential Honors from USD, was honored by the Girl Scouts, and the UCSD Chancellor's Medal for Community Service. She was honored with the Neil Morgan Award for LEAD San Diego and was awarded an Honorary Doctorate from the California State University system. Shiley received the Lifetime Achievement Award from San Diego Business Journal's *Women Who Mean Business*, the Non Profit Director of the Year Award from the Directors Forum in 2011, the Corporate Directors Forum Director of the Year Award in 2012, and the San Diego County Board of Supervisors' award for community service in 2015. She was awarded the Herb Klein Spirit of San Diego Award for her significant and lasting impact on our region in 2016. In addition, Shiley received an honorary doctorate degree in Fine Arts from the California State University, San Diego in 2008, an honorary doctorate degree in Humane Letters from the University of Portland in 2018, and a Lifetime Legacy Award from UCSD in March 2024.

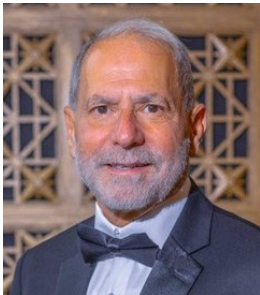
