#### **Recommendations of Presidential Task Force**

#### 13 December 2016

As a Task Force, we were charged by President Harris to examine what USD is currently doing to support and protect our immigrant and international student and employee population and to make recommendations for what additional steps and actions should be taken to support those who may be affected by possible changes in immigration policy and enforcement.

In line with Catholic Social Teaching and its emphasis on the dignity of the individual, as well as USD's strategic plan for the future, which calls on our community to "confront humanity's urgent challenges," we agree that it is vital for President Harris to lead the entire USD community in protecting and supporting DACA, undocumented, immigrant and refugee students, employees and family members, as well as others experiencing marginalization, including international students. As Bishop McElroy stated at the Catholic Immigration Integration Initiative Conference held on our campus on November 28, though these may be days of uncertainty and waiting, "in that waiting, we stand with the undocumented and the refugee communities in this moment of suffering in a bond of accompaniment and protection which will only grow stronger as the threats grow more profound." We believe that these recommended actions are important in demonstrating to the most vulnerable members of our community that the University of San Diego stands by them, with renewed solidarity and as a revitalized and united community, and reaffirms its "bond of accompaniment and protection" to them.

Consistent with the actions urged by the community petition submitted to President Harris and Provost Allen on November 22, as well as the resolutions adopted by the Academic Assembly of the College of Arts and Sciences and University Senate, we are recommending that USD take specific and concrete actions to enhance the welcoming and inclusive environment that we already seek to provide to all members of our community, to reaffirm that USD does not and will not voluntarily undertake actions to enforce U.S. immigration laws beyond what we are legally required to do, and to enhance the services and support USD provides to members of our community who are feeling vulnerable or marginalized.

#### These are our recommendations:

First, we recommend that President Harris take the following actions to reaffirm USD's commitment to USD's core principles:

 Endorse the statements made by Bishop McElroy on November 28, 2016 at the Catholic Immigrant Integration Initiative Conference held in the Joan B. - 2. Reaffirm USD's rejection of all forms of racial, ethnic, and national origin discrimination whether or not done under the guise of immigration enforcement.
- 3. Pledge renewed university efforts and resources to support DACA, undocumented, immigrant and refugee students, employees and family members, as well as others experiencing marginalization, including international students, through increased campus outreach, through counseling and pastoral care, through legal advice and support, using our legal clinics and marshalling other legal resources from our law school and community, as needed, and through all other services available at USD.
- 4. Reaffirm USD's commitment to diversity and inclusion and access to higher education by creating an atmosphere of trust, safety and respect in a community characterized by a rich diversity of people and ideas by urging all members of our campus community to exemplify respectful behavior and to speak out against any acts of discrimination directed at members of our community because of their immigration status, race, ethnicity, national origin, religion or identity.
- 5. Reaffirm the importance of a vital and productive bi-national relationship with Mexico and a thriving cross-border region to the strength of USD's research and teaching mission and our role as an anchor institution in the broader community.

Consistent with the principles of sanctuary, we also recommend that President Harris reaffirm the following:

- USD will not share information about a student's or employee's immigration status with ICE or other law enforcement agencies except in response to a subpoena, warrant, or other legal mandate, where exigent circumstances exist, or where the student or employee voluntarily consents to the disclosure.
- 2. USD will not verify the immigration status of applicants for undergraduate or graduate programs who are residents in the United States.
- 3. USD will not assist ICE or other law enforcement agencies in immigration enforcement activities on the USD campus except where we are required to do so in response to a subpoena, warrant, or other legal mandate, or where exigent circumstances exist.
- 4. The Department of Public Safety, a non-sworn department, will not engage in immigration enforcement activities, will not ask for or otherwise collect immigration status information about our students or employees, and will adhere to the same principles as those described above.

Third, we recommend that, consistent with the USD vision of "setting the standard for an engaged, contemporary Catholic university," President Harris commit USD to taking a leadership role in integrating regional efforts to assist immigrants and others experienced marginalization and in fostering education and a community dialog on issues of immigration, discrimination and intolerance, including in the following ways:

- 1. By integrating USD's efforts with those of the Diocese of San Diego and other Catholic groups to coordinate their support of immigrants and refugees throughout the region.
- 2. By coordinating with local university officials at nearby institutions, including SDSU, UCSD, SD City College, and the San Diego County Community College District, to integrate their support of DACA, undocumented, immigrant, refugee and international students and to encourage local and state authorities to take additional measures to protect our immigrant population.
- 3. Convene campus leaders to plan a series of forums and public lectures, beginning early in the Spring Semester, to foster a better understanding of the issues that divide our country, especially immigration, and a respectful and constructive dialogue to address the issues of injustice, intolerance and discrimination and to seek agreement on common principles for all of us to better serve immigrants and others who are experiencing marginalization in our communities.
- 4. Support cross campus collaboration and interdisciplinary teaching and scholarship on immigration and refugee issues; race, ethnicity, and civil rights; cross-border ties; and community engagement, for the purpose of increasing the visibility and impact of the innovative work on these issues already underway at USD.

Finally, the Task Force encourages the allocation of financial and other resources required to support and sustain these commitments and initiatives. We recommend that President Harris commit his support to establishing each of the following, which we believe are essential to enabling USD to meet its commitments:

- Publish a website with all documents, resources, and activities related to the inclusion and
  protection of non-U.S. citizens in our community and our outreach efforts to the broader
  community. This comprehensive website should include information about all the counseling,
  pastoral care, and legal services available on and off campus. Examples are attached of
  information developed by the Task Force on USD's Commitment to Provide Legal Services,
  Immigration Law Resources and USD's Integration Efforts with other Catholic, Educational and
  Social Service Organizations.
- Identify the Center for Inclusion and Diversity as the "one-stop" and focal point for information and referrals regarding support services offered to DACA, undocumented, immigrant and refugee students, employees and family members, as well as others experiencing

- marginalization, in partnership with the International Center, which will remain the focal point in support of international students.
- 3. Designate a group of community members to monitor the recommended actions, to ensure that USD's commitments are being fulfilled, and to report to the President at the conclusion of the Spring Semester. If President Harris desires, the members of the Task Force would be willing to continue to assist in this process.

# **Attachment: USD's Commitment to Provide Legal Services**

Our DACA students and other students and staff with immigration concerns are understandably distressed about the prospect of actions against immigrants under the new federal administration. It is incumbent upon us to address these fears by, among other things, being proactive and supportive in concrete ways.

First, we commit to providing legal counseling for our students and staff with immigration concerns. San Diego enjoys many local resources in that regard. First and foremost is the School of Law's immigration clinic, which provides legal services to low income individuals. In addition, there are several local organizations providing pro bono or low fee immigration legal services. These include: Casa Cornelia Law Center, Legal Aid Society, ABA's Immigration Justice Project, Catholic Charities, and Jewish Family Service. Some of the local organizations also offer informational presentations on topics like knowing your rights and staying safe. Second, we commit to being prepared to mobilize in the event that any of the more extreme actions some fear become a more serious threat. Such mobilization will require collaboration, and USD will be able to draw upon many legal resources beyond those of the law school and the organizations listed above. Numerous law school alumni practice immigration law locally and throughout the State. In addition, the San Diego County Bar Association has an immigration practice section, and the American Immigration Lawyers Association has a local chapter with more than 200 members. In January, we will begin conversations with them about the logistics of joint mobilization efforts.
