His continuing role as editor in 2017-18 will include offering our authors a set of guidelines and synthesizing their findings in an editorial introduction.

The purpose of this travel is to meet with Professor Eyal at a large, international conference being held in Prague at that time to continue collaborative work on cultural differences in media experiences. While there, he plans to also collect interview and focus group data for the book length project from Czech individuals. The proposed travel experience will greatly enhance his research agenda, particularly as it relates to expanding expertise beyond American media.

He will conduct archival research on the history of curriculum in the Philippines and interview Department of Education personnel, teacher education faculty, and local school leaders and teachers about the recent reforms.

The first is to witness and document in Palestine, the 70th commemoration of the start of the Nakba. The second purpose of the fieldwork is to record a group of interviews with college age Palestinian men and women reflecting on their experiences of living an ordinary life, while existing under the extraordinary conditions of military occupation. His time in the West Bank will be spent mostly in the cities of Jerusalem, Ramallah and Bethlehem, with day trips to Hebron, Nablus, Jericho and Jenin. He plans to attend and document visual art exhibitions, university and community lectures, academic and activist panel discussions, as well as public ceremonies. Dr. Halaka's research and creative work as a visual artist are directly informed by narratives of displacement, exile, survival and resistance, that I have recorded over the past decade with refugees and survivors of political trauma. The proposed research trip will provide a very important opportunity to witness/document commemorations of loss and survival and will further shape his artwork by deepening my understanding of the Palestinians' anti-colonial struggle.
