

- For USD one upper division 3 semester unit or more elective course needs to be in Marketing and another needs to be in Finance. If taken at Catolica Lisbon some possibilities include: Product and Customer Marketing (MKTG 494), Marketing in the New Era (MKTG 494), International Corporate Finance (FINA 405 + FINA 391), Capital Markets and Institutions (FINA 494). Can also combine some special topics
- 3. USD requires 124 total units to graduate, 48 units of which must be upper division (300 or 400 level courses). Catolica Lisbon requires 92 ETCS to meet their degree requirements.
- 4. Some of the core courses at USD will also need to meet the diversity, inclusion and social justice (DISJ) requirements and one course in advanced writing (CADW) core.

- The International Business Major at USD requires six internationally electives or a total of 18 semester units, including BUSN 361 (3 units). Some electives at Católica Lisbon include International Corporate Finance (FINA 405 + FINA 391 – 4 units); International Economics (ECON 333 + ECON 391 – 4 units); Development Economics (ECON 494 – 2 units); Economic Globalization (ECON 494 – 2 units). Note that some upper division core courses at USD also serve as electives in the IB Major.
