



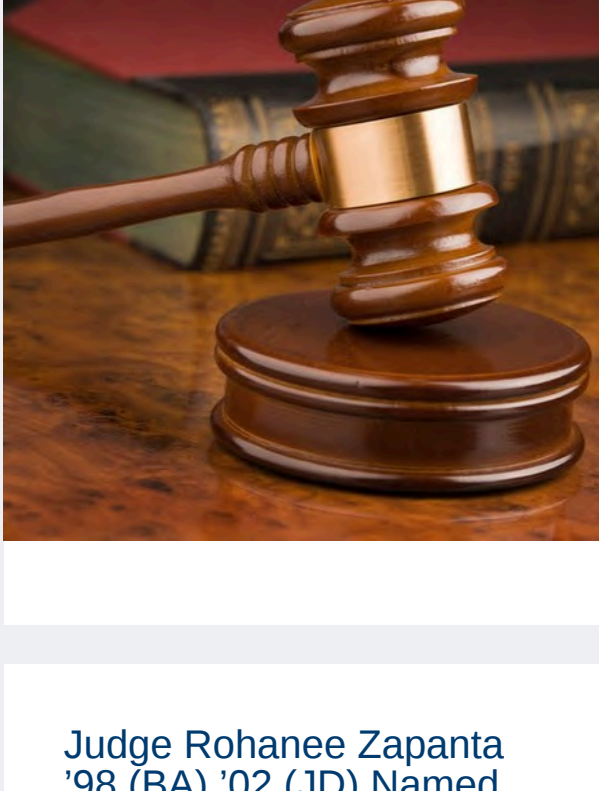
Celebrating USD's 75th Anniversary and the School of Law's 70th Anniversary
