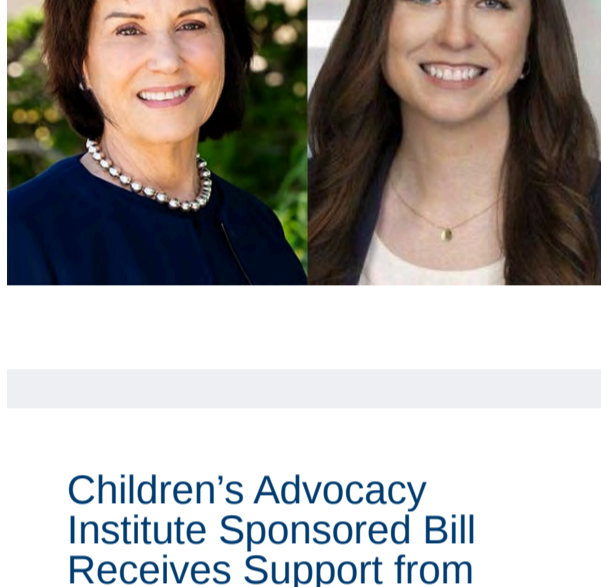


USD School of Law and Instituto Tecnológico Autónomo (ITAM) de México Kick Off International Tax Executive Program
