By signing this Volunteer Coach Agreement ("Agreement"), I acknowledge and agree to the following:

1. I wish to participate as a volunteer coach for the following activity: _____.
2. I am volunteering for this activity for the following date(s): _____.
My status as a volunteer shall be limited to the dates listed above. After such dates, I will no longer be a volunteer of the University of San Diego ("University") or the School of Law and will need to enter into a separate agreement for any subsequent activities.
3. My volunteering does not make me an employee, contractor, agent, or vendor of, nor establish any other similar relationship with, the University or the School of Law. I understand and agree that I will not be paid for my volunteer service. I have not been promised and do not expect any compensation in any form. I agree my volunteering does not make me eligible for any employee benefits offered by the University.
4. The Faculty Director of Advocacy Competition Programs has sole discretion over my eligibility to volunteer, and may terminate, restrict, and/or otherwise modify my volunteering at any time for any reason. I further agree that I shall act only at the direction of the Faculty Director of Advocacy Competition Programs and that my duties and responsibilities are limited to those duties and responsibilities that I am given by the Faculty Director of Advocacy Competition Programs.

5. I understand that I may be reimbursed for reasonable expenses associated with my volunteer activity, provided that those expenses have been pre-approved in writing by the Faculty Director of Advocacy Competition Programs. I further understand original, itemized receipts are required for any reimbursement, which will only be made up to the amount actually raised and pursuant to the law student organization handbook and shall be made in accordance with the University's expense reimbursement policies and procedures.
6. I agree to be bound by all policies, requirements, and procedures of the University and School of Law.
7. I agree to not represent to anyone that I am acting on behalf of, represent, or otherwise am affiliated with the University or the School of Law in relation to this competition except to the extent permitted by the Faculty Director of Advocacy Competition Programs.
8. I understand that I am not authorized to sign any contracts or otherwise encumber or commit (financially or otherwise) the University or the School of Law. I further agree that I shall not and cannot obligate or bind the University in any manner whatsoever with respect to any third party, and nothing herein contained shall give or is intended to give any right to a third party.
9. I am physically and mentally able to perform the volunteer activity. If I have any limitations, I will inform the Faculty Director of Advocacy Competition Programs.
10. I agree to and will sign the [Assumption of Risk and Release of Liability Form](#), attached to this agreement. I understand and agree that the University disclaims any and all responsibility for any loss, injury or damage to person or property in connection with my volunteering.
11. I agree to and will sign the [Consent and Release Form](#), attached to this agreement, governing the University's ability to use my name, photograph or likeness, as well as my testimonials, quotes, and comments for publicity, promotion, advertising, fundraising, administrative, academic or educational purposes. I understand I may opt out of or limit the usage of my name, photograph or likeness by contacting the Faculty Director of Advocacy Competition Programs.
12. I shall not use USD's trademarks, logos or insignia, or otherwise identify the University in any form of publicity, disclosure or sale without the advance written permission of University.
13. I shall be responsible for my acts and omissions, as well as those of my agents or associates. I agree to defend, indemnify, and hold the University harmless from any and all liability, claims, demands, suits, costs, charges and expenses, including without limitation attorneys' fees, to the extent caused by negligence or willful misconduct by myself or my agents or associates.

14. I agree that any disputes arising out of or relating to my volunteering shall be governed by the laws of the State of California and shall be resolved through binding arbitration under the applicable rules of JAMS. The venue for the arbitration shall be in San Diego, California. I agree to be responsible for my own costs and attorneys' fees incurred in connection with any such dispute.
15. This Agreement may not be amended, except through a writing signed by authorized representatives of USD. The Agreement further may not be assigned. If any provision of this Agreement, or part thereof, is held invalid, void or voidable as against public policy or otherwise, the invalidity shall not affect other provisions, or parts thereof, which may be given effect without the invalid provision or part. To this extent, the provisions, and parts thereof, of this Agreement are severable.
16. This Agreement is entered into for good and valuable consideration, and the University would not permit me to volunteer without my signing this Agreement.
